Lost Super

Are you missing something

Here's something to think about.....

There is over \$12 billion in lost superannuation accounts

Could yours be one of them?

With many Australians changing their employers on a regular basis, losing track of small superannuation accounts is becoming more and more common.

Below are a few useful contacts that could help you track down any lost super:

SuperSeeker (www.ato.gov.au/superseeker)

The ATO looks after a database called the Lost Member Register (LMR). This includes details of lost members for accounts held by super funds, approved deposit funds, eligible rollover funds and retirement savings accounts. If you have changed jobs, addresses or names you may be listed on the LMR.

You can search the LMR online by putting in your name, date of birth and Tax File Number. If there is a match, you can fill in a transfer form to have this account transferred to your current super fund. If you have any further questions, you can contact the ATO on 13 10 20.

AusFund (www.unclaimedsuper.com.au)

This fund is a large eligible rollover fund commonly used by industry super funds. If you were a member of an industry fund and have lost contact with them, you could have an account with AusFund

You can complete an online enquiry form on the above website by putting in your name and date of birth. AusFund will search their records and advise you if you do have an account with them. Please note, AusFund advise that it may take up to 6 weeks to complete the search. If you have any further questions, you can contact AusFund on 1300 361 798.
